# **Change in Organisation and Personnel**

#### **Object of Organisation Change**

For the expansion of global business of the Suzuki Group, from the long-term perspective, the Company aims to make a structure to comprehensively manage approximately 65,000 persons of human resources across the Group, as well as to fulfill human resources education.

Also, the Company has terminated the divisional system and adopted the deputy executive manager system to crossfunctionally manage operations.

#### [Positions in charge of Human Resources]

- The Company has terminated Administration, and newly established the position in charge of Human Resources that plans and promotes the plans and systems in employment, education, nurturing, career path, etc. of human resources in the Suzuki Group as a whole. Other newly-established positions in charge are Engineering Human Resources, Domestic Human Resources, Overseas Human Resources, and Human Resources Development.
- Under each positon in charge of Human Resources, Human Resources Department is placed to function as a secretariat.
